# EXHIBITOR CONTRACT

**As an exhibitor at this gun show, I agree to abide by the following terms and conditions:**

I agree that I will not deliver any weapon at the show in violation of the waiting period required by California law. I UNDERSTAND THAT ONLY CURIO, RELIC OR ANTIQUE LONG GUNS (100 year rule) ARE EXEMPT FROM THE WAITING PERIOD, AND THAT ALL HANDGUNS, INCLUDING CURIO AND RELIC HANDGUNS, ARE SUBJECT TO THE WAITING PERIOD AND D.R.O.S. REPORTING REQUIREMENTS and that the sale or transfer on any firearm, except as noted above must be completed through a fully licensed dealer.

I understand that California law requires that all firearm transactions must be processed by a licensed dealer in compliance with D.R.O.S and other requirements, and I agree not to deliver any firearm without complying with the transfer procedures required by California law. Further, I agree to comply with all federal and local laws and with all Fair Board and show rules.

**SAFETY RULES: I AGREE TO INDIVIDUALLY CHECK AND CLEAR EACH AND EVERY FIREARM WHICH I BRING TO THE SHOW OR WHICH ANY PERSON THAT I BRING TO THE SHOW HAS IN THEIR POSSESSION. THIS INCLUDES PERSONAL "CARRY" GUNS AS WELL AS ALL OF THE GUNS ON MY TABLE, UNDER MY TABLE, IN MY BRIEFCASE OR IN MY PURSE OR ANY PLACE IN MY POSSESSION OR IN THE POSSESSION OF ANY-ONE WHO IS WITH ME.**

I WILL CHECK AND CLEAR EVERY FIREARM IN MY POSSESSION PRIOR TO ENTERING THE BUILDING, AND TIE THE ACTION WITH A NYLON TIE PRIOR TO PLACING ANY FIREARM ON MY TABLE FOR DISPLAY. I agree to remove all detachable magazines from any firearms in my possession or in my display. I understand that no loaded magazines are permitted in the show for any reason.

**AMMUNITION: NO LOOSE ROUNDS OF AMMUNITION ARE PERMITTED IN THE SHOW**

I will display ammunition ONLY in original factory boxes or in closed containers (including heavy-grade zip-lock bags) secured with tamper-proof seals such as colored tape or stick-on paper seals, to prevent access to the ammunition by member of the public. All ammunition will be displayed and sold in accordance with CA DOJ rules and regulations. Limited information is available at time of printing, it is the vendor's responsibility to be familiar with current regulations.

I understand that smokeless powder is permitted ONLY contingent upon strict compliance with guidelines established in the National Fire Code and by the California State Fire Marshal. NOTE: California limits quantities of smokeless powder at any vendor's location to a maximum of twenty pounds in any one location; smokeless powder may be displayed and sold only in sealed containers.

**BLACK POWDER IS EXPRESSLY PROHIBITED.** Some facilities prohibit the possession on ANY quantity of smokeless powder in the show. Check with show management for local restrictions.

**STRICTLY FORBIDDEN is the law, display, possession, or bringing onto the grounds of the event the following:**

Any parts or accessories that may be used on any firearm as a sound suppressor or silencer, or that may be used to convert semi-automatic firearms to full automatic fire.

Live cannon, artillery shells, mines, grenades, or other destructive devices.

Tear gas, or other antipersonnel sprays, shields, shells, canister, projectiles, or other disabling devices such as repellents

Stun guns, unless power sources for such devices are packaged separately.

Ammunition for which the propellant is not contained in a metal casing (i.e. case less ammunition)

Firearms capable of firing case less ammunition.

Gun replicas (non-guns), except as used by vendors for demonstration purposes.

I understand that this gun show is advertised to the public as a family event, and that pornographic materials or items with obscene language or graphics, including magazines, pictures, videos, and bumper stickers, T-shirts, hats or other items which are offensive to families or individuals are strictly prohibited. (Racial, ethnic or hate materials, including but not limited to Nazi, Communist or white supremacist propaganda are strictly prohibited.) Display or sale of any prohibited items will result in the immediate removal of the offending dealer from the show and will be grounds for being banned from any future shows. **NO ONE-DAY RENTALS NO UNAUTHORIZED VENDORS TO JOIN OR SHARE TABLE SPACE.**

I agree to indemnify and hold harmless, including any legal expenses, the producers of this show, the managers of this show, their employees of agents and the owners, or the operators and employees of the facility in which the show is conducted, and the State of California and its political subdivisions, from any damage, loss or legal action resulting from the failure to observe the preceding, or any intentional, unintentional or negligent act resulting in injury or damage whether committed by myself or any individual sharing my space or employed to work in the space.

**ALL DOGS MUST STAY BEHIND TABLE AT ALL TIMES, EXCEPT TO BE TAKEN OUTSIDE (when allowed, some venues prohibit dogs)**

**I understand and agree that show producers are not liable for loss or theft of, or damage to, merchandise, and that I am responsible for my own merchandise at all times during which the show is open to the public and during all hours which the show is closed to the public.**

**I understand and agree that any activities at this show which are in violation of any federal, state or local law will be grounds for expulsion from this show and exclusion from any future shows.**

***There will be no refunds on tables unless we are notified at least 4 weeks prior to the show.*** The show committee reserves the right to refuse the application or remove any individual display which is found to be objectionable. All Federal, State and Local firearm regulations must be observed. The facility, Blair and Kathy Snyder, and Hildy Langewis, are not responsible for lost, damaged or stolen items.
